Terms and Conditions—Livestock Equipment Incentives

Program Offer: The Program covers products purchased and/or services rendered on January 1, 2010. This program is only available for agricultural accounts. Maximum total rebate for all equipment included on this form is \$1200 per year.

Equipment Requirements

- x Livestock Waterers: Waterers must be designed for year-round usage without freezing. Requires a maximum power input of 175 Watts, a minimum of 2 inches of tank insulation, and lid covers to qualify. There is no minimum power input for heaters (if any) as a waterer is designed to operate in Iowa during the winter without the water freezing.
x Heat Lamps: Must be UL listed with a power input of 175 Watts or less. For replacement of 250 Watt heat lamps.
x Single Crate Heating Pads: Must be UL listed with a power input of 85 Watts or less.
x Double Crate Heating Pads: Must be UL listed with a power input of 170 Watts or less.
x Heat Lamp or Pad Controller: Heat pad controllers must allow control of heat output automatically with temperature. Heat lamp controllers must allow for variable intensity of heat lamps either through automatic sensor control or manual heat intensity adjustments that are integrated into heat pads do not qualify.

Application and Eligibility Process
