## Prenotification Instructions for Contractors For Ground Water Heat Pump Installations

**Contractors Incentive:** (Receive \$ 200 if criteria are met for only GWHP.)

-  Meet all criteria for installation
-  Provide a heat loss/heat gain calculation
-  Complete the Notification Form

### Criteria for the Ground Water Heat Pump installation:

-  The notification form needs to be completed and returned to the cooperative prior to installation.
-  The primary heating system must be electric and able to provide 100% of the structure's heating requirements.
-  The ground water heat pump must be sized for a minimum of 85% of the total heat loss.
-  100% of the domestic water heating must be electrically heated, but water heater can not be on the electric heat rate.
-  Must have a meter installed outside of house to record usage of GWHP.  
(The water heater usage is NOT to go through this meter)
-  Eligible for the Electric Heat Rate at currently 7.10 cents per kWh  
(This rate is only from October to May billing months)

**Our rebate for the member is \$ 250 plus \$ 350 per ton up to 20 tons.**

**We will need a copy of the receipt showing the brand, model, serial number of the unit.**
