## ***ELECTRIC WATER HEATER AGREEMENT***

This Agreement made this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, between T.I.P. RURAL ELECTRIC COOPERATIVE, hereinafter called the “Cooperative”, and \_\_\_\_\_ hereinafter called the “Member-Consumer”, whereby the parties mutually agree to the following:

1. The Cooperative agrees to refund to the Member-Consumer

- \$175.00 – 40 gal. or larger energy efficient (Energy factor .90) electric water heater.
- \$650.00 – ENERGY STAR Heat Pump Water Heater (stand alone units)
- \$150.00 – 40 gal. or larger Resistance Storage Unit with geothermal heat recovery desuperheater.

After the hot water heater is installed the Member-Consumer agrees to an inspection of the installation by a Cooperative employee. Payment will be made after the Cooperative has inspected the water heater. The Member-Consumer will not be eligible for another refund on a water heater installation at this location during the manufacturer’s tank warranty period.

2. The premises on which the water heater is installed shall be served by the Cooperative.

3. The Cooperative and/or its power supplier, at their expense, has the right to manage (control) the Member-Consumer’s electric water heater load at such times and periods as determined by the Cooperative and/or its power supplier. The load will not be controlled for more than four (4) consecutive hours in any twenty-four (24) hour calendar day. The control equipment may be installed at any time after the execution of this Agreement.

4. The Cooperative and/or its power supplier shall not be liable to the Member-Consumer for any damage or loss which may be alleged to result from any malfunction of the control equipment installed under this Agreement, or from any electric power interruption.

This Agreement shall be binding upon the successors, assigns, or transferees in interest of the parties. These terms and conditions are accepted by the following authorized signatures.

## Terms and Conditions - Water Heater and Go Electric Bonus

**Program Offer:** The Program covers products purchased and/or services rendered on or after **January 1, 2021**.

### Eligibility Criteria for Water Heaters:

1. The water heating equipment must be electric.
2. Water heaters must be used for domestic water heating only and cannot be used in conjunction with radiant space heating systems (e.g. boiler for in-floor or baseboard heating).
3. Electric storage water heaters must have a 40 gallons or larger storage tank.
4. Electric water heaters not supplemented by geothermal equipment must be energized.
5. There is a limit of two resistance storage water heater unit rebates and three total water heater rebates per home.
6. Heat pump water heaters must be ENERGY STAR® qualified units. Limit of 2.
7. Electric storage water heaters must have GAMA/AHRI certified capacity and energy factor ratings.

### Eligibility Criteria for Go Electric Bonus (for water heaters):

1. This is a one time bonus per residence, only available to new construction and residences that haven't received a past rebate on an electric water heater.
2. Please discuss incentive with your cooperative staff if you are considering converting to an electric water heater to ensure eligibility.

### General Terms and Conditions

Rebates shall be pro-rated based on the percent of power supplied by the utility if the customer has distributed generation.

**Application Information:** Missing or incorrect information on the application may delay processing and delivery of the rebate. An invoice is required and should include specific product information, including the brand, model, serial number and date of purchase of the energy efficient measures. Other information including manufacturer's equipment performance sheets may be required upon request.

The Utility reserves the right to verify sales transactions and to have reasonable access to the Customer's facility to inspect pre-existing equipment (if applicable) and energy efficient measures installed under this program.

**Warranty Information:** The Utility makes no warranties, expressed or implied, with respect to equipment operation, material, workmanship or manufacturing. The Utility does not guarantee that a certain level of energy or cost savings will result from the use of products covered by this program.

**Limitation of Liability:** The Utility's liability in connection with this program is limited to paying the rebate specified when all terms and conditions have been satisfied. Under no circumstances shall the Utility be liable for any consequential or incidental damages or tax liability resulting from participation in this program.

**Participant Certification:** Participating Customer certifies that he/she purchased and installed the equipment listed on their application at the defined location served by the Utility. The Customer agrees that all information provided is true and that he/she has conformed to all program requirements. If the equipment and application does not comply with the Utility's rules and qualifications, the rebate amount may be denied or adjusted.

**Program Changes/Termination:** The Utility reserves the right to extend, modify (including incentive levels) or terminate this Program at any time without prior or further notice. The Customer is responsible for checking with the Utility to determine whether the program has been changed or is still in effect.

**Customers must apply for rebates within six (6) months of the purchase date (as shown on the Customer's invoice) and are subject to the current year program offer if received after January 31st.** Past eligibility, however, does not guarantee that equipment will meet criteria for current programs in effect.
